- The number of section of the school shall be restricted as per appendix V of affiliation bye laws and shall not be increased and maintain section according to appendix V w.e.f. session 01.04.2020.
- 10. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity related to running of school affiliated to CBSE. The school shall also be liable to bear all legal charges incurred by the Board, if any, arising out of these circumstances.

- The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board. .
- Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.
- The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ information/data submitted by the School to the Board.

School is required to submit a single revised teaching staff list.

Special Condition

1. The number of section of the school shall be restricted as per appendix V of affiliation by laws and shall not be increased and maintain section according to appendix V w.e.f. session 01.04.2020.

2. The School is required to submit Recognition Certificate as per the Section 18 of Right to Education Act, 2009 from the concerned State Government. If the same has not been obtained earlier, the school is directed to apply for Recognition Certificate immediately and submit the same to CBSE office within a period of one year
